COMMUNITY SERVICES INFLATABLE RULES & REGULATIONS

SAFETY RULES:

Warning: these rules MUST be followed to avoid any serious injury.

There are inherent many risks, in the participation in or on any *inflatable* interactive device. Participants and supervisors should be aware that they have a duty to exercise good judgment and act in a responsible manner while in or on the inflatable activity.

- Individuals with head, back, or any other disabilities, pregnant woman, small infants and others susceptible to injury from fall, bumps or bouncing are not permitted in or on in the inflatable unit any time.
 - Supervision by a qualified adult attendant is required at all times.
 - Remove shoes, eyeglasses and any sharp object before using the unit.
 - o No food , drinks, gum, pets or silly string
 - o EXIT IMMEDIATELY if unit begins to lose air. USE exit door and escape hatches
 - Riders SHOULD all be of compatible age size. 40" is the standard cut off height group riders together above or below that height limit.
 - Inflatable bouncy castle must be anchored to the ground at all the times with stakes or sandbags and should never be removed. Never use outdoors if wind is 20km/h +
 - Keep children away from the blower at all times
 - The blower must be operated by adults only
 - In the unlikely event of a blower failure please evacuate children immediately
 - Unload and deflate any inflate structure in the case of heavy rain or high winds (over 25 km/h)
 - Make sure children are bouncing away from others and away from the sides
 - o DO NOT jump onto or off the *inflatable*. Climb on/off in a safe and slow manner.
 - Do not exceed the recommended child capacity listed on the inflatable.
 - No climbing the wall of the bouncer
 - The bouncer must be fully inflated before any children are allowed inside.
 - The bouncer must be fully inflated until everyone is out.
 - Keep the bouncer a safe distance from fire hydrant, water, walls, fence or other obstructions.

USER ACKNOWLEDGEMENT:

I acknowledge that I am responsible for picking up and dropping off the inflatable from the Garcelon Civic Center. I acknowledge that I am responsible for returning the inflatable in a clean and completely dry state. I acknowledge that if MDSS staff deem the inflatable unacceptable upon its return, I will be charged a cleaning fee of no less than \$50. I acknowledge that that if MDSS staff do not deem it possible for the item to be returned in its original state of cleanliness, they can deny my request for use at their discretion.

I acknowledge that "The Municipal District of St. Stephen, its respective servants, agents, employees, or officials" (collectively referred to as the "MDSS") are not responsible for any injury, loss or damage of any kind sustained by any person while participating in any and all activities associated with use of the Community Services inflatable bounce house including injury, loss, or damage which might be caused by the negligence of the MDSS.

I agree to provide a certificate of insurance listing the Municipal District of St. Stephen as an additional insured for the event. This policy must cover bodily injury and property damage in an amount of not less than two million dollars (\$2,000,000), with the Municipal District of St. Stephen added as an additionally named insured. All policies and certificates are subject to MDSS approval.

I shall comply with and abide by all applicable insurance requirements and shall not do or omit to do anything that would impair or invalidate the insurance policies.

I confirm that the inflatable is for community use and I shall not charge money to individuals for its use.

I agree to waive all claims that I have or may in the future have against the MDSS arising out of any aspect of my participation in the programs or activities and to release the MDSS from any and all liability resulting from any loss, damage, expense or injury, including death, that I may suffer or that my heirs or assigns may suffer resulting from my participation in these programs or activities.

By executing this document, I agree to hold the MDSS harmless and indemnify them in conjunction with any injury, disability, death, or loss or damage to person or property that may occur as a result of engaging in activities offered.
