

BUSINESS IMPROVEMENT AREA BY-LAW

WHEREAS Mr. William Garcelon of the Town of St. Stephen has submitted a sufficient petition pursuant to the Business Improvement Areas Act, requesting that the area hereinafter described in this By-law be designated as a business improvement area pursuant to the provisions of the said Act.

THEREFORE THE COUNCIL OF THE TOWN OF ST. STEPHEN ENACTS AS FOLLOWS:

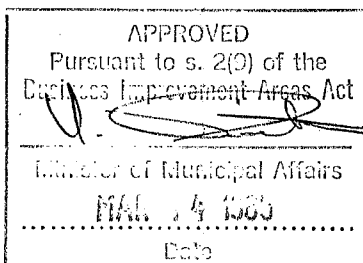
1. Pursuant to the provisions of the Business Improvement Areas Act, the Council of the Town of St. Stephen designates the following portion of the Town of St. Stephen as a business improvement area:

All that certain lot, piece or parcel of land and premises lying and being in the Town of St. Stephen, in the County of Charlotte and Province of New Brunswick, bounded and described as follows:

Beginning at 99 King Street and proceeding southerly on the said King Street to the intersection of King, Milltown Blv'd and Budd Avenue, all properties fronting on both the east and west side of the aforementioned King Street; thence easterly on Budd Avenue to the intersection of Princess Street, all properties fronting on the north and south side of the aforementioned Budd Avenue and on the south side to the St. Croix River; thence westerly on Milltown Blv'd to Watson Street all the properties on the south side of Milltown Blv'd to the St. Croix River and all properties on the north side of the aforementioned Milltown Blv'd and to include that area bounded by Burton Avenue from Milltown Blv'd to King Street.
