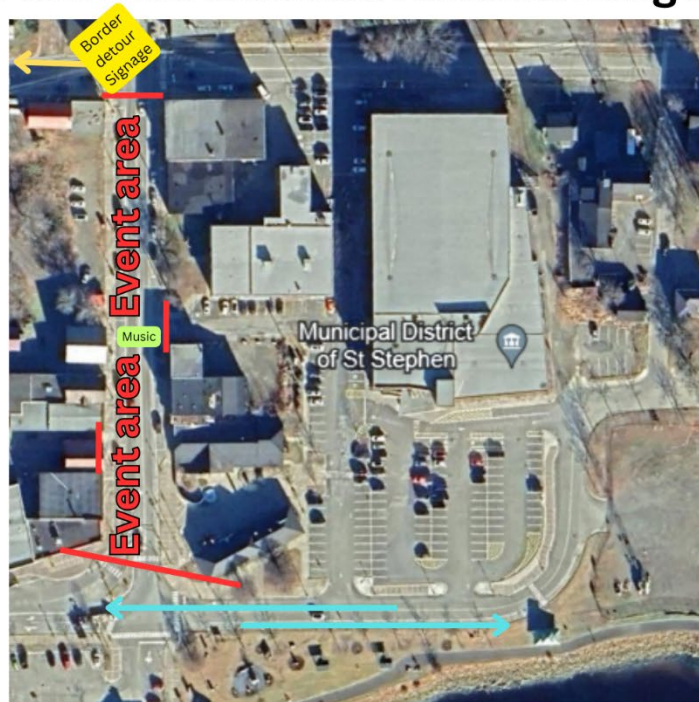
Aug. 8th – 10am-4pm – MDSS Street Fair
